On March 25, 2003 the United States Department of Transportation (DOT) issued Final Rule HM 232, Hazardous Materials Security Requirements.

This rule requires persons and organizations involved with transporting hazardous materials to develop and adhere to a security plan for hazardous materials by **September 25, 2003**. The security plan must include an assessment of possible transportation security risks for hazardous materials shipments and appropriate measures to address the assessed risks. All hazardous materials stakeholders are impacted. Written guidelines and controls must be evident and demonstrate a review and upgrade of security measures, including the following:

1. Personnel Security **2. Unauthorized Access** **3. Enroute Security**
